### 4. President's Report – B. Simmons

a. Ryan Neumyer of Esquire Association Management had submitted a proposal to the Board for review. A transition fee was paid for Mr. Neumyer to review the governing documents thoroughly. The Board was given the opportunity to ask any questions or voice any concerns. Assuming a January 1, 2024 effective date, a letter would go out to homeowners around the first week of December. The rate charged will be locked-in for a period of two years. The majority of Associations do not have an increase in rate after the two years. Any proposed increase would be included in the budget, which will be given to the Association in October. There will be a team of three managers that will serve as a point of contact. If hired, Mr. Neumyer will attend the Annual Meeting to make a presentation and answer questions.

The Board discussed the previous presentation from years ago by PMI, a recent presentation from McNaughton Property Management, and the presentation by Esquire Property Management.

M. Yagel motions to hire Esquire Property Management, L. Godoy seconds, motion passes with all in favor. J. Davis will contact Mr. Neumyer to begin the transition process.
