Want to make it a little easier to pay your dues? Why not try your bank's Bill Payer service? Many institutions offer free bill payer, or offer the service for a nominal fee. Check with your financial institution and set up a bill for Allenview Homeowners Association, P O Box 1007, Mechanicsburg, PA, 17055. Just reference your name/address as the account number.

REMINDER....

If you own a home (single family or townhouse) in Allenview you MUST get approval from the Architectural Control Committee (ACC) to make *any* changes to the exterior of your home. This includes, but is not limited to, roofs, siding, decks, doors, fencing, satellite dishes, landscaping, and outside lighting. You may obtain an ACC form on the website at <u>www.allenview.org</u> or request one from Joann Davis. No changes are to be made until approval in writing *has been received*.

ACC forms must be received prior to the Monday of the *week before* the regular Board meeting (4th Tuesday of the Month) in order to receive approval that month.

Reminder of Sign Policy

Just a reminder that Allenview has a very strict policy with regard to signs, including signs for the sale of your home. One sign is permitted on the property to advertise its sale. If you are a corner property, you do not get two signs.

Only on the day of an open house may you have one directional sign positioned at each of the two entrances to the development. These directional signs must be removed immediately after the open house ends. No other directional signs are permitted. As the homeowner, you are responsible for complying with these rules. Please do not assume that your real estate agent knows these rules. All non-conforming signs will be removed immediately.
