ALLENVIEW POOL PARTY AGREEMENT

I agree that I am responsible for scheduling my pool party in writing with Allenview Pool by filling out the Allenview Pool Party Registration Form.

I understand that my deposit of \$25.00 is non-refundable, and that there are **NO** exceptions to this rule (inclement weather, fecal contamination, etc.).

I understand that in the case of inclement weather, fecal contamination, or any other event that may cause an early closure of the pool, Allenview Pool management has the right to cancel my party. I also understand that in the event of an unforeseen cancellation, my non-refundable deposit may be used to reserve the pool at a different date.

I agree to pick up all party trash in the pool area when my party is over and clean all of the pool's items I may have used.

I agree and to supervise all in attendance, both in the pool and on the grounds of the pool.

I agree to be responsible for any damages to Allenview Pool, Allenview Pool grounds, or Allenview Pool facilities that are caused by my actions or the actions of anyone attending my party.

I have read the Allenview Pool Rules and Regulations and agree to abide by them and by the rules for the proper use of the Allenview Pool facilities, and I ensure that anyone attending my party will also abide by these rules.

I hereby agree that I will indemnify and hold harmless the staff and management of the Allenview Pool from any and all claims, suits, losses, fines, or other expenses arising out of, based on, or incurred because of injury or loss to any person or persons or any damage to property sustained or which may be alleged to have been sustained as a result of using Allenview Pool.

Allenview Pool Rules and Regulations

1. **Absolutely no glassware in the pool area.** Plastic only.
2. No diapered children in the big pool.
3. Should fecal contamination occur, the pool must be closed for 24 hours. No exceptions.
4. Children in baby pool must be supervised by an adult at all times.
5. All children under the age of 8 must be accompanied by an adult (16 and older)
6. No underage drinking. No public drunkenness.
7. No diving, running, or rough horseplay in the pool area.
8. No vulgar language or actions.
9. Adult swim called every hour for 15 minutes. No one under 18 years of age may be in the pool during this time.
10. No hanging on pool ladders.
11. Lifeguards are working to monitor the safety and care of pool patrons. They are not babysitters.
12. No one but the lifeguards may sit at the lifeguard table.

Lifeguards have the authority to remove individuals from the pool area
